

Student Enrollment Contract

As an element of the admissions process, each parent and student of Florida Gulf Coast University Collegiate High School (FGCU CHS) must sign an agreement committing adherence to the following principles of enrollment.

1. I understand my FGCU course work will have the same depth, breadth, rigor and pace as all University students regardless of age or grade placement.
2. I understand my FGCU courses are subject to the same standards, policies, and responsibilities as other college students unless otherwise restricted by federal, state or local requirements.
3. I understand curriculum content, evaluation, and selection of instructional materials are the prerogative of the university instructor and will not differ for FGCU CHS students from that presented for traditional college students.
4. I understand FGCU is an open campus. While at FGCU, I will attend classes with non-high school aged students; I will encounter students of a variety of ages and backgrounds.
5. I understand FGCU CHS Coordinator is the first point of contact for parents who wish to discuss academic progress in a course, schedule a conference, or request information about school or classroom activities.
6. I understand I cannot DROP a university course unless approved by FGCU CHS Coordinator, home high school counselor and my parents.
7. I understand as an FGCU CHS student, I must maintain a university GPA of at least 2.5 and I will be placed on academic program probation for failure to maintain a 2.5 GPA. I understand if placed on academic program probation, I must earn a minimum semester GPA of 2.5 for each semester after being placed on program probation, until my cumulative GPA reaches 2.5 or higher; I understand failure to do so is grounds for removal from the program.
8. I understand if I receive a grade below C-, I will be placed on academic program probation. I understand if I receive a second grade below C- and my GPA is below a 2.5, I will be removed from the program.
9. I understand it is incumbent upon me to attend all scheduled classes. I understand I will be placed on program probation for any non-attendance issue. Furthermore, I acknowledge continued absences will result in my removal from the CHS program.
10. I understand if I am withdrawn from a course due to absences, a "W" is assigned to that course on my FGCU transcript; my high school transcript will reflect an "F" for the corresponding high school course.
11. I understand if I am removed from the program, I will return to my home high school.
12. I understand as an FGCU CHS student, I must abide by all FGCU CHS and applicable FGCU policies including, but not limited to my home high school district School Board *Code of Student Conduct*.
13. I understand that completion of high school graduation requirements does not guarantee completion of an AA degree. To receive an AA degree, I understand that I must meet all program requirements identified in the FGCU Catalog at the time of my initial admission.
14. I understand that I will be expected to sign an agreement outlining my responsibility for all instructional materials, textbooks, and equipment issued to me.

By signing this Agreement, I acknowledge that I have read and understand the information contained in this contract; of my own free will, I agree to comply with and be bound by the terms contained herein.
