FGCU smoking policy on main campus is as follows:"Smoking shall be permitted in the following areas:1. Outdoors in designated smoking areas. 2. In personal vehicles on campus. 3. In FGCU residential areas, as designated by the Office of Housing and Residential Life. Smoking in any area, indoors or outdoors, other than the areas specified above is prohibited.Leadership in communicating this policy to the university community and ensuring compliance shall be the responsibility of all university administrators and supervisors. Administrative Services shall maintain the designated smoking areas."

FGCU smoking policy in residence halls is as follows: "Designated smoking areas are the outside smoking areas indicated by signs and/or benches and cigarette disposal boxes. Any University staff member or student can request that any other staff or student adhere to the smoking policy. Smoking outside of the designated smoking areas may result in a fine of \$25 for the first offense, a \$50 fine for the second offense, and a \$100 fine as well as conduct action for the third offense. Cigarette butts must be properly disposed of. Hookahs are prohibited on housing property." (As per page 21 in the Housing Community Guidebook)
