All Applicants

- Submit two official transcripts from each college/university attended.* Transcripts must be in the original sealed envelope from the institution to be considered official
- Sit for the GRE, MAT, or GMAT (according to program requirements) and request scores be sent to FGCU
- Complete all supplemental requirements of the program

*Previous and current students of FGCU are not required to submit a new immunization record, transcripts (unless not already on file), or the application fee. Transcripts from institutions attended after enrollment at FGCU are still required.

International Applicants

- International students (and U.S. students with international transcripts) must have a course by course evaluation of international transcripts by an approved private company, such as, World Education Services, Josef Silny and Associates, INC or AACRAO
- Applicants from countries where English is not the official language must submit a minimum TOEFL (Test of English as a Foreign Language) score of 550 (paper-based test) or 213 (computer-based test) or 79 (Internet-based)

Admission Requirements

Master of Science in Criminal Forensic Studies (M.S.)

Concentrations in Forensic Behavioral Analyst and Human Identity and Trauma Analyst

Applicants must have an undergraduate cumulative GPA of at least 3.25 and the GRE with a minimum combined score of 1100 on verbal and quantitative sections. Applicants must submit official GRE scores, a supplemental application, three reference rating forms or letters of recommendation, and a statement of career goals. Master of Public Administration (M.P.A.)

Concentrations in General Public Administration, Management, and Environmental Policy

Applicants must submit scores from GRE or MAT taken within the last five years, supplemental application, letter or statement of career goals, and three reference rating forms or letters of recommendation. Prerequisite undergraduate coursework is also required. Visit <http://cps.fgcu.edu/PA/MPA/admissions.asp> for more information.

GPA and test scores are evaluated according to the following formula: (Combined score of GRE quantitative and verbal sections) + (GPA for the last 60 semester hours attempted at the upper-division undergraduate level X 200) must equal or exceed 1600; or (MAT percentile rank for intended major) + (GPA for the last 60 semester hours attempted at the upper-division undergraduate level X 18) must equal or exceed 100.

Applicants must have a minimum 3.0 GPA in the last 60 credit hours of the baccalaureate degree, submit GRE or MAT scores, supplemental application, personal statement, and three letters of recommendation. Applicants must have an undergraduate cumulative GPA of at least 3.0 and a score of 900 or more on the GRE. Applicants must submit official GRE scores, three letters of recommendation from persons qualified to judge the applicant's academic and professional potential, and a personal aspiration statement (300-500 words).
