**PURPOSE AND EFFECT:**

The University proposes to review FGCU Regulations/Rules 6C10-7.001 and 7.003, F.A.C., to determine whether amendments are appropriate in light of the 2007-08 General Appropriations Act, and any amendments or repeals of provisions in the Florida Education Code, Chapters 1000-1013, Florida Statutes, or amendments to or promulgation of other statutes during the 2007 Legislative Session or resolutions of the Board of Governors that relate to the same general subject matter. These amendments may include tuition or fee changes, or new fees, and it may be necessary to repeal rules or to promulgate additional rules not listed above that relate to the same general subject matter.

**SUBJECT AREA TO BE ADDRESSED:**

The Chapter describes the University's finance and accounting policies and the general tuition and fee schedules. The University will review FGCU Regulation/Rule 6C10-7.001, F.A.C., Tuition and Fees, and Regulation/Rule 6C10-7.003, Special Fees, to determine whether any updates or amendments are appropriate effective with the Fall 2007 Semester.

**SPECIFIC AUTHORITY:** S. 7, Art. IX, Fla. Const., 120.54, 1001.74, FS.

**LAW IMPLEMENTED:** 2007-08 General Appropriations Act, 1001.74, 1009.21, 1009.24, 1009.25, 1009.26, 1009.285, 1009.29, FS.
