Introduction

The Quarterly Briefing shall provide the Board of Trustees with a set of periodic reports and performance indicators designed to give an overview of the University's major goals and achievements in academic affairs, faculty and student body demographics, research, economic development activities, facilities development, institutional advancement, and financial management.

The Quarterly Briefing will be updated as necessary and distributed to the Board of Trustees prior to each of its quarterly meetings.

Notes and Highlights

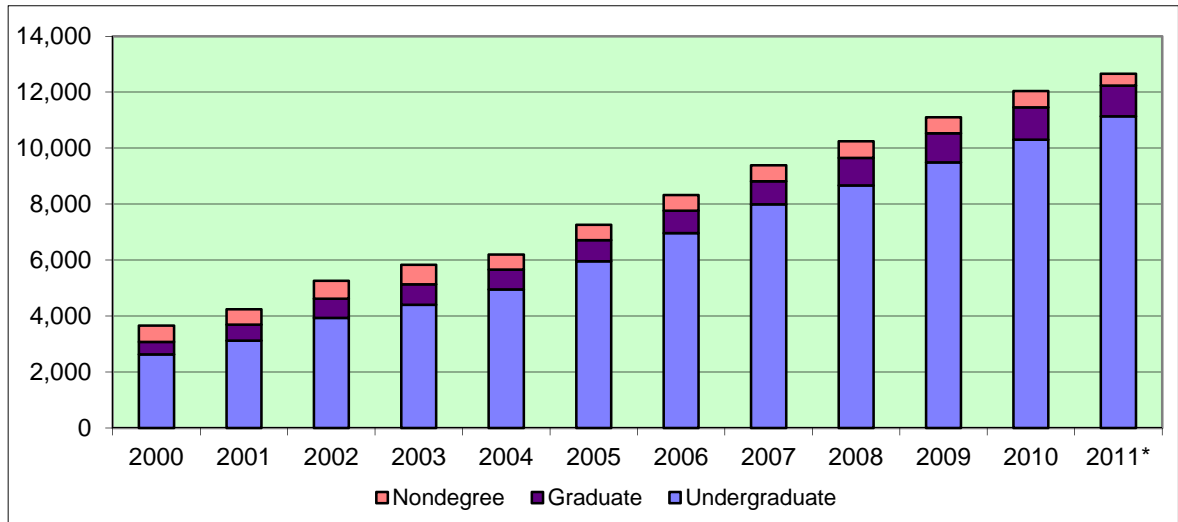
- Preliminary fall 2011 headcount enrollment is 12,661, 5% above fall 2010.
- The final fall 2010-11 annual fundable FTE was 7598, 8% ahead of 2009-10.
- The number of new freshmen on first day of class increased to 2576, 16% above fall 2010.
- In 2010-11, 1616 bachelor's degrees were awarded, 11% above 2009-10.
- Master's degrees increased to 385, 7% above 2009-10.
- FGCU awarded its first doctorates: 19 awarded in 2010-11.
- FGCU also awarded its first specialist degrees: 5 awarded in 2010-11.
- Undergraduates make up 88% of the total student population.
- Freshmen make up 28% of the student body.
- Among undergraduates, 79% are full time.
- Students 24 or under represent 79% of the student body. The fastest rate growth is among students under 20.
- Hispanic students are 16% of the total student population, increasing 11% over last fall.
- The number of African American students increased from 719 in fall 2010 to 864 fall 2011, showing the fastest growth among the racial/ethnic groups.
- The College of Arts and Sciences enrolls 28% of all students.
- The College of Health Professions has the highest rate of growth at 18%.
- Section 4 has the 2011-12 Operating Budget. Tables 4.1 through 4.4 provide actual expenditures through 2010-11 and estimated budget for 2011-12.

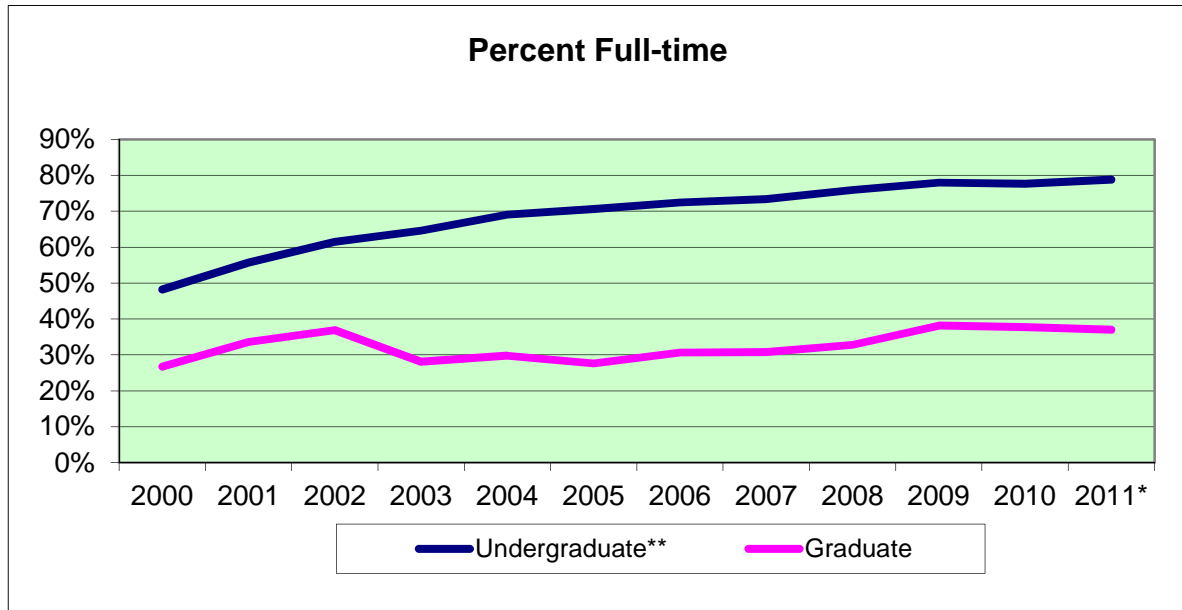

Table 1.2 - Full-time Attendance by Level, Fall Terms



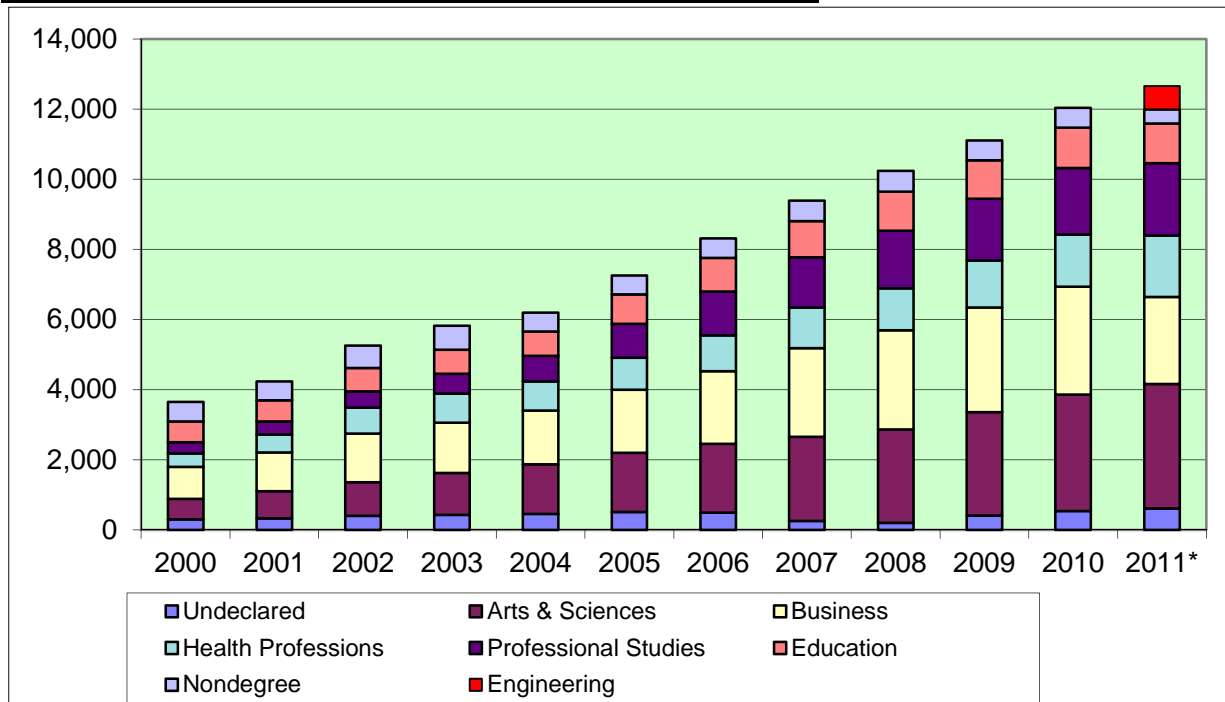

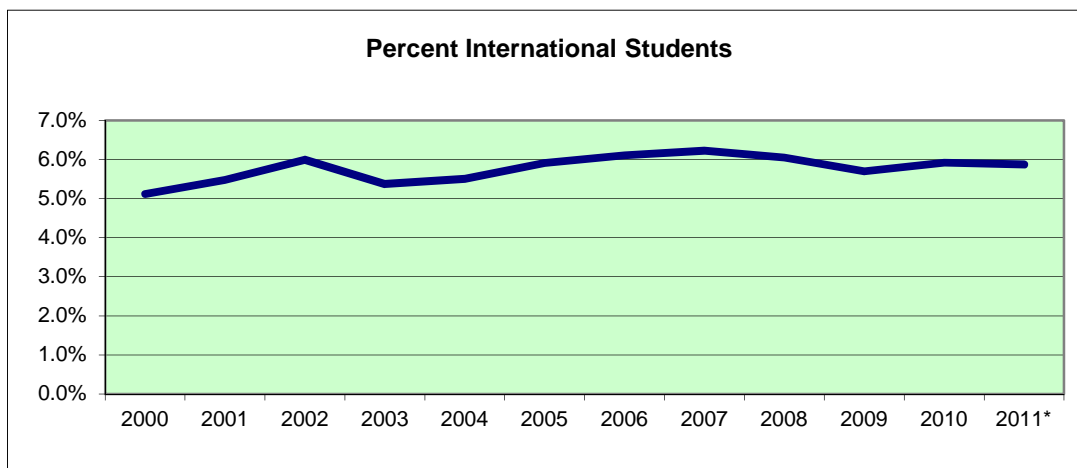

Table 1.4 - Headcount Enrolled International Students, Fall Terms

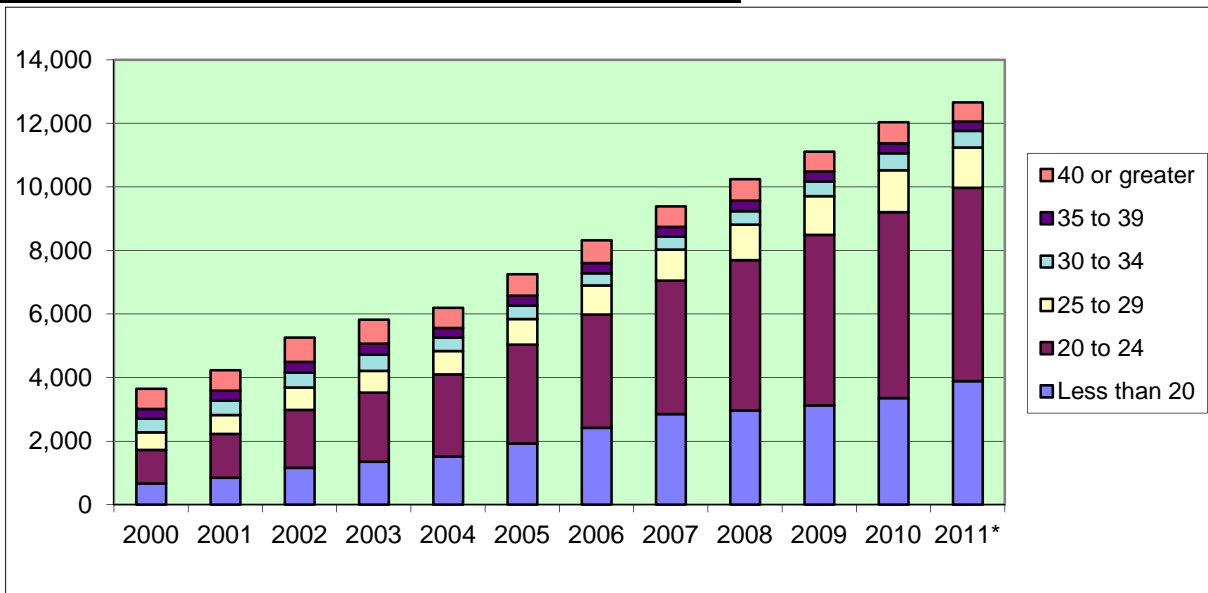

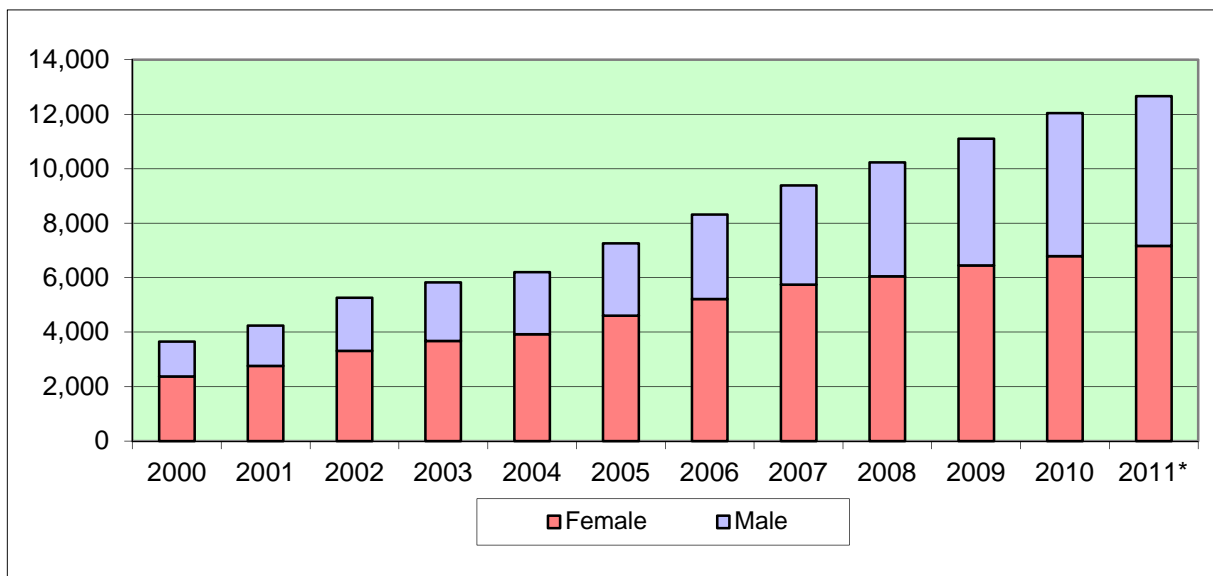
Table 1.5 - Headcount Enrolled by Age, Fall Terms

Table 1.6 - Headcount Enrolled by Gender, Fall Terms

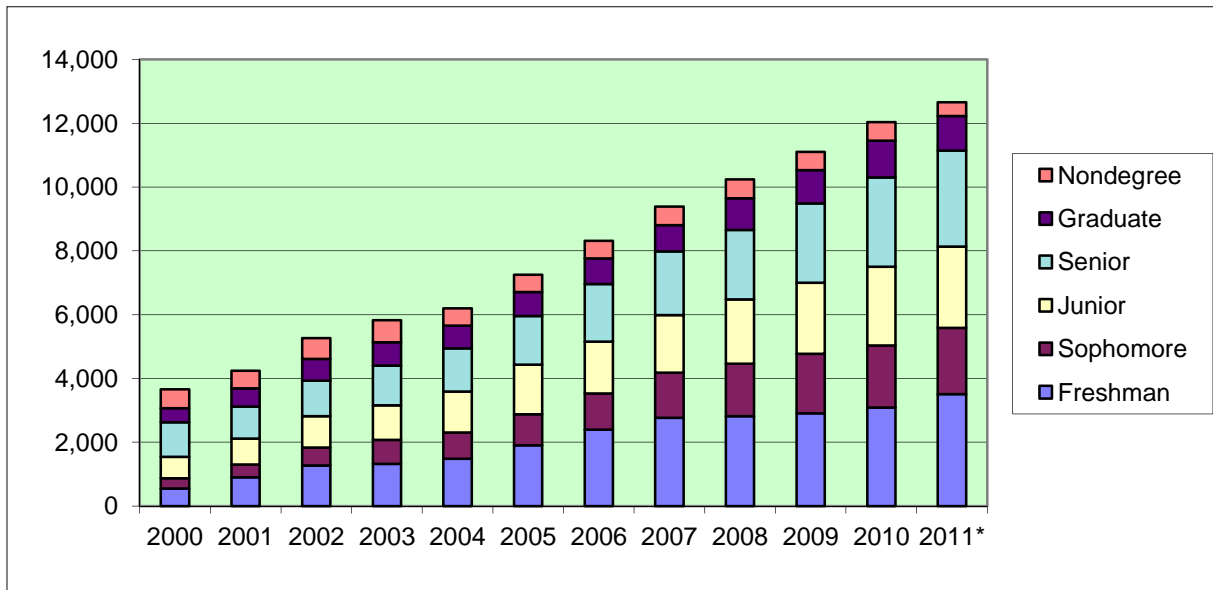

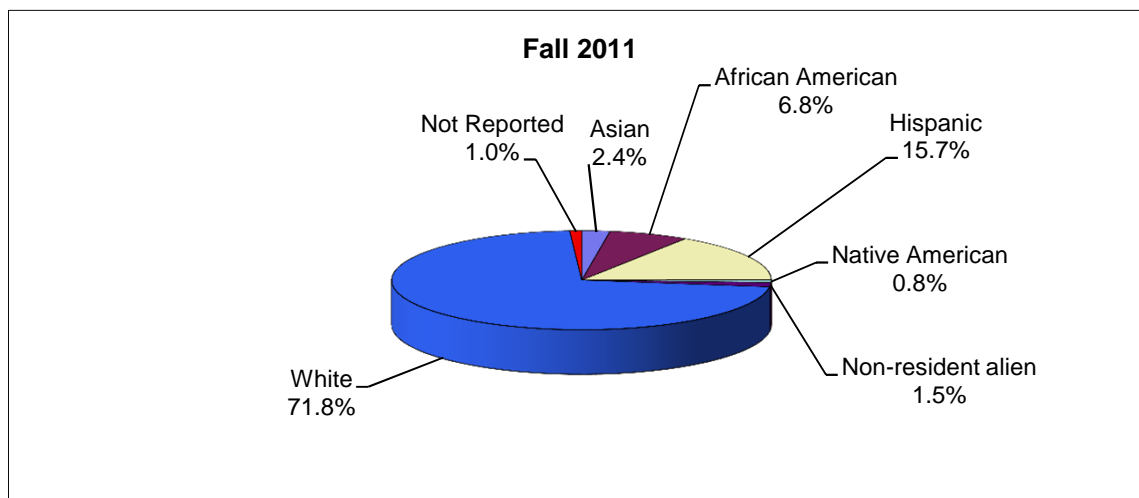

Table 1.8 - Headcount Enrolled by Ethnicity, Fall Term

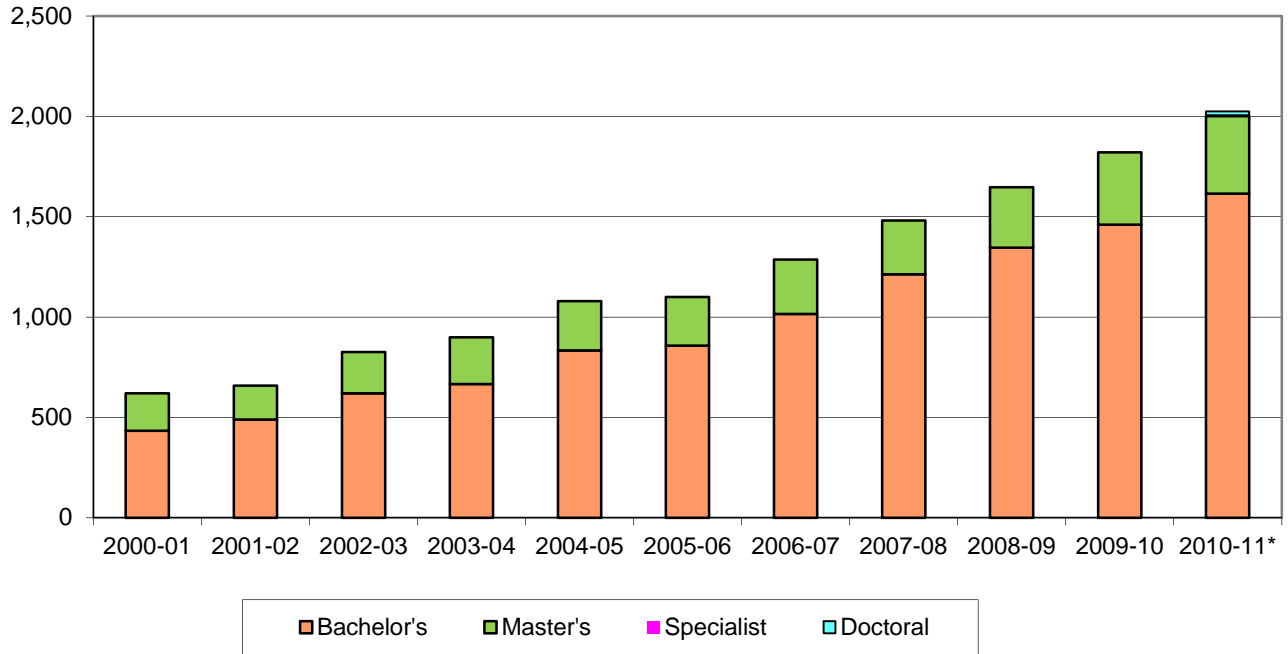

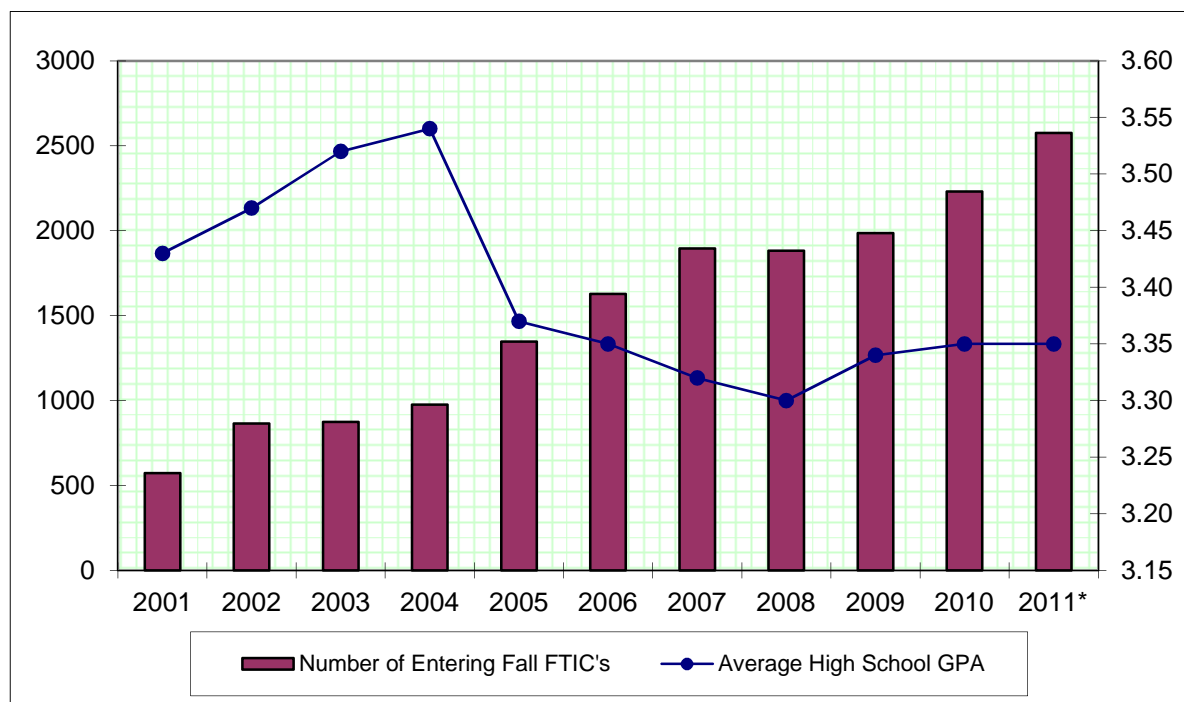
Table 1.9 - Degrees Granted by Academic Year

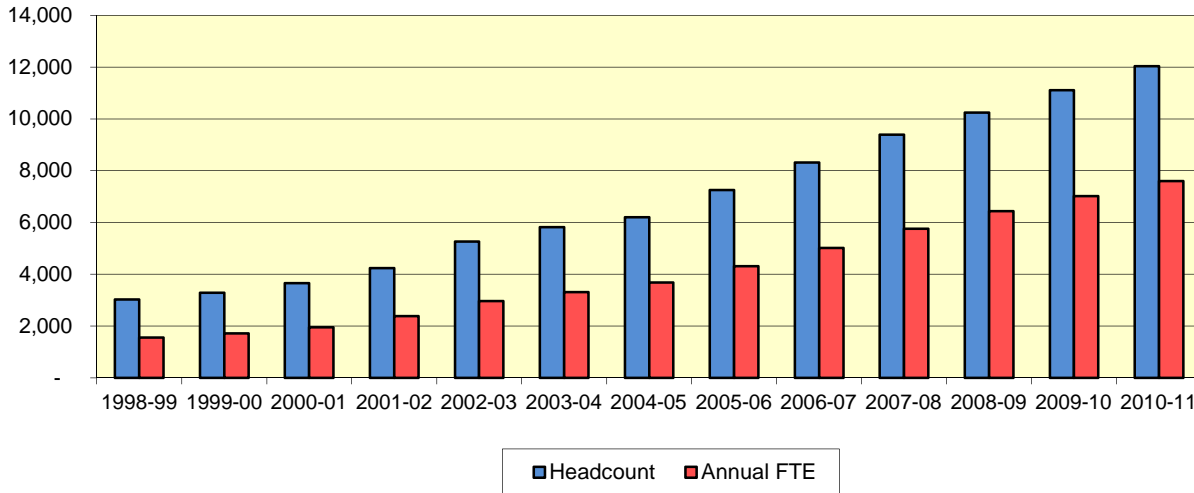

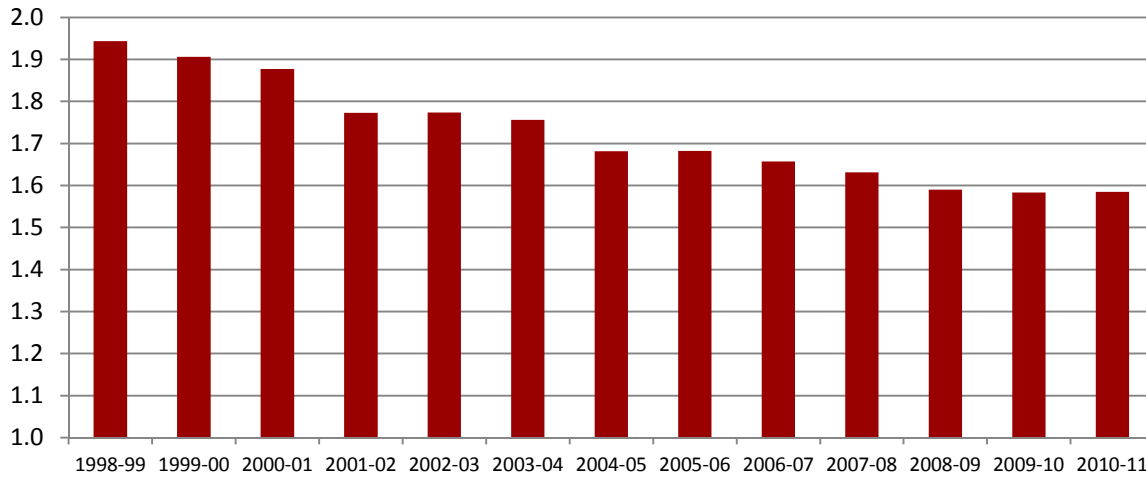

Headcount Per UG FTE

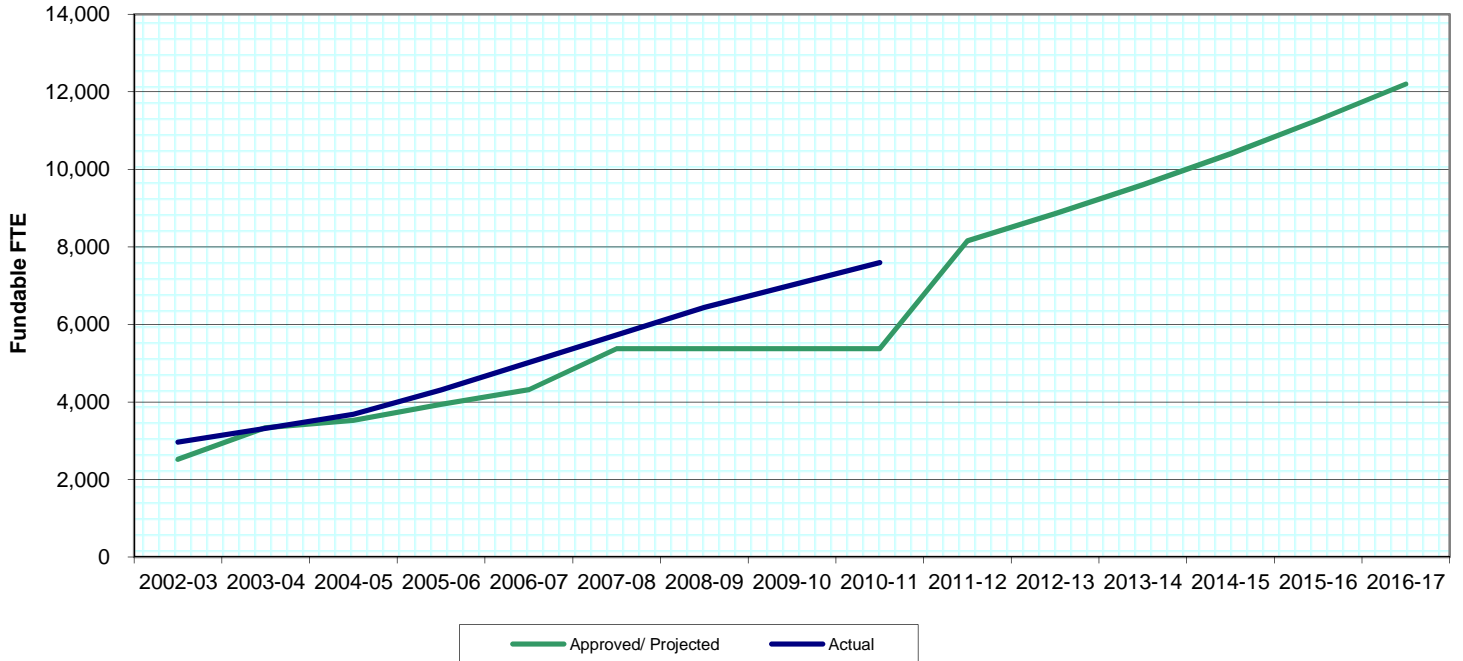

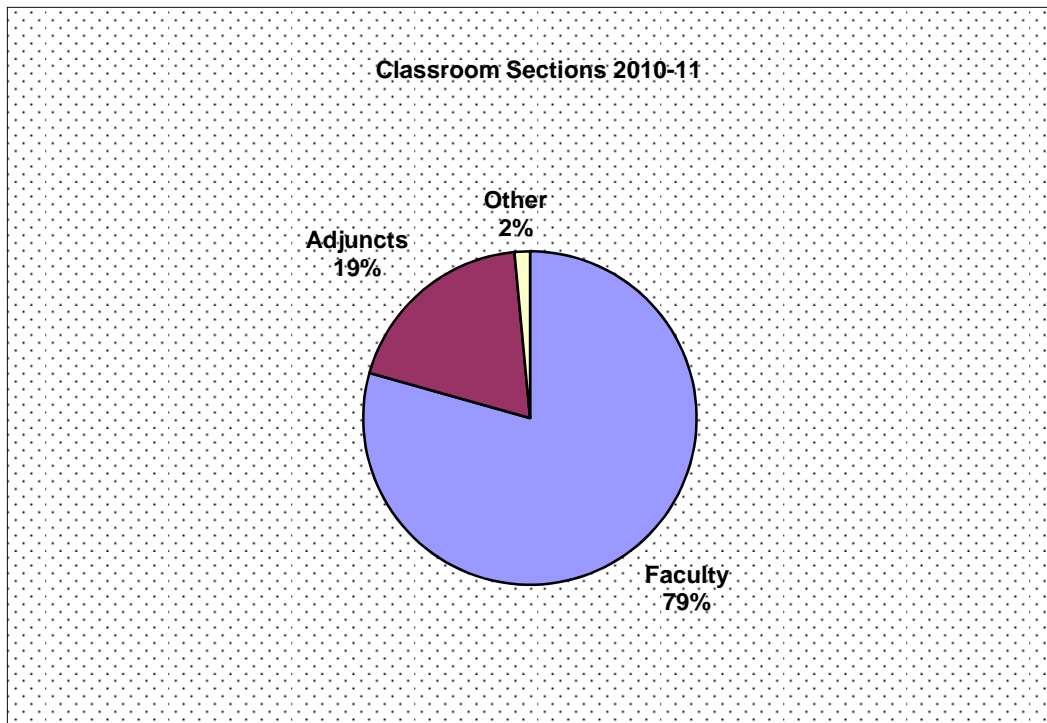
Table 2.6 - SUS Cost Per Credit Hour

Distribution of Classroom Sections by Faculty Type

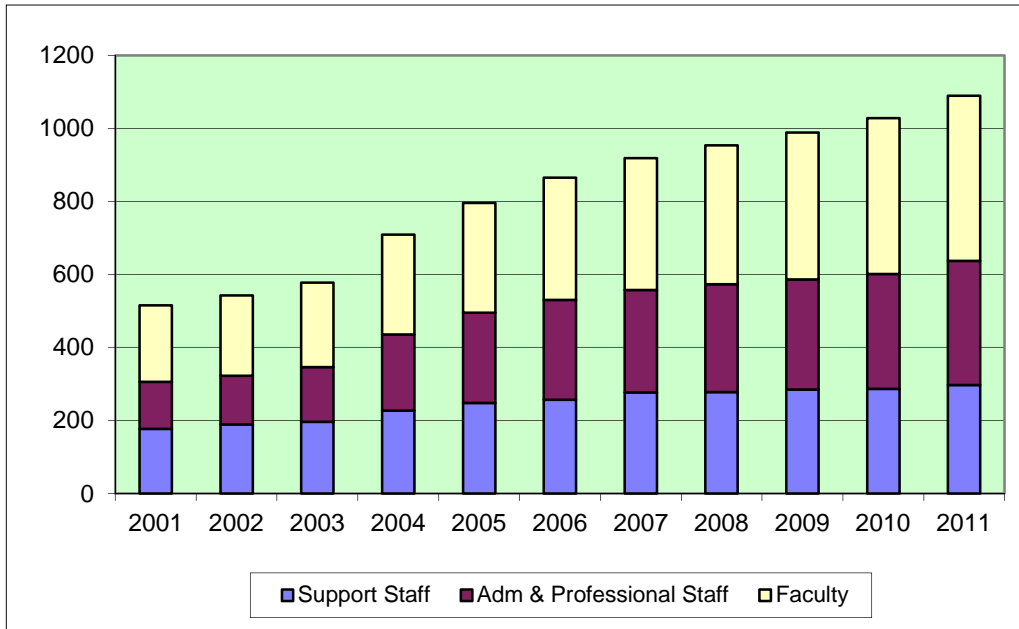

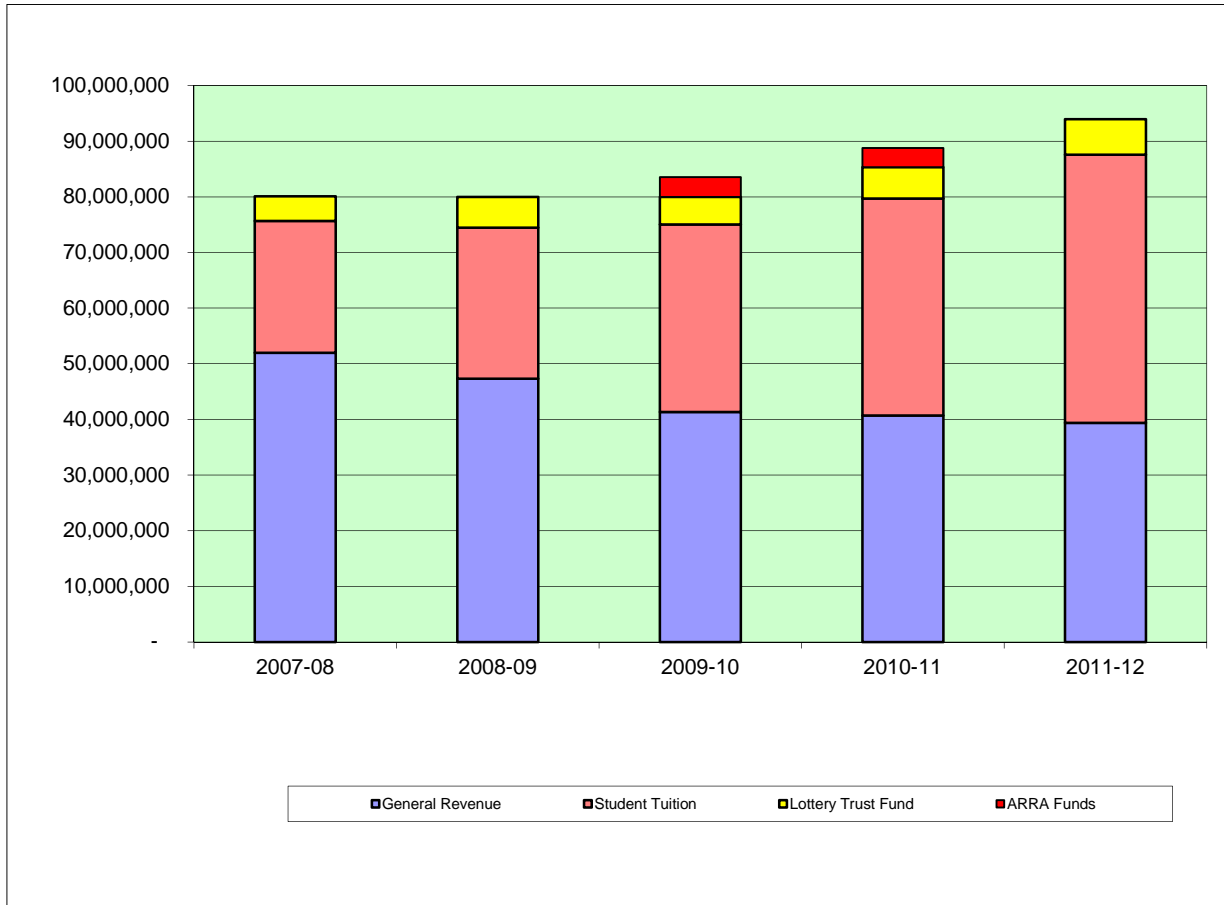

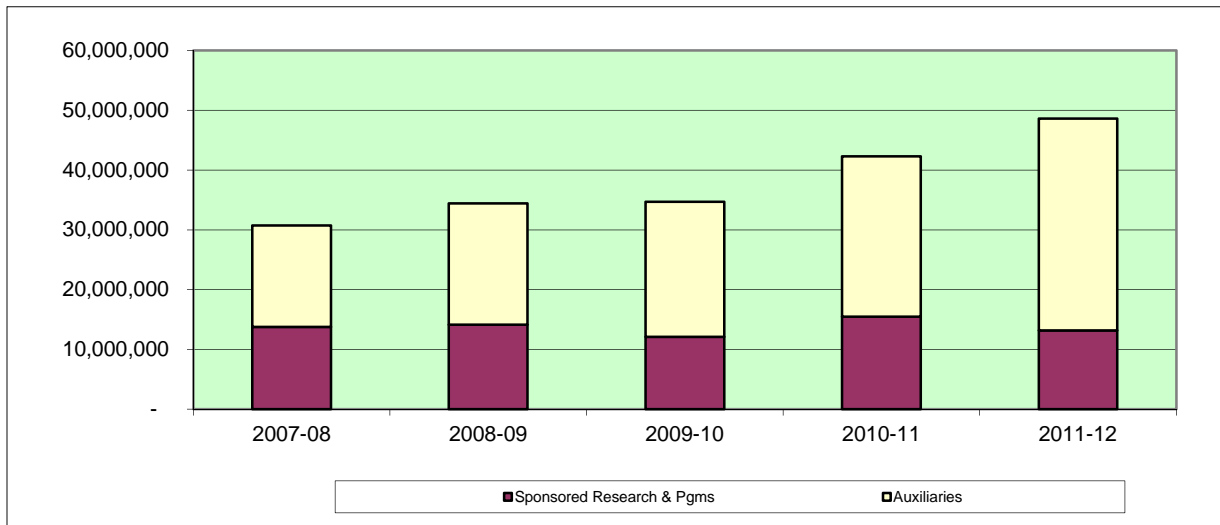
