### Program Description

The Master of Arts (M.A) in school counseling offer students both coursework and 700 hours of practicum and internship experiences that satisfy both national standards and state certification requirements. Graduates are eligible for certification and employment as school counselors in Florida. The degree programs are nationally accredited by the Council for Accreditation of Counseling & Related Educational Programs (CACREP), the Florida Department of Education and Counselor for the Accreditation of Educator Preparation (CAEP, formerly the National Council for Accreditation of Teacher Education).

The Counseling Department offers an opportunity to earn a single MA degree with both the Clinical Mental Health Counseling major and the School Counseling major. Students must meet initial admissions requirements of both programs to qualify for this option. Students may elect the dual major option at any time after admission to one of the programs and prior to graduation. Students initially admitted into the School Counseling major will take an additional 27 credits. Students must complete all degree requirements for both majors including passing all subsections of the FTCE, General Knowledge, Professional Educator Examination and the Guidance and Counseling Subject Area Exam prior to graduation. ### Admissions Requirements

- FGCU graduate application
- Official academic transcripts from every college or university attended
- Baccalaureate degree from a regionally accredited institution
- Graduate Record Exam (GRE) or Miller's Analogies Test (MAT) official scores
- Submission of three favorable recommendations from professionals in the field
- Statement of career goals (2-3 pages)
- Meet one of the following (GPA & Test Scores are required from ALL applicants regardless of which criteria are met):
  - GPA of 3.0 or higher on a 4.0 scale in the last 60 hours of undergraduate coursework
  - GRE minimum score: 151-153 Verbal & 143-144 quantitative
  - 400 or higher on the MAT
- Evidence of Florida Teacher or Educator certification (if applicable) OR
- Passing score on FTCE subsections including: General Knowledge Test, Professional Educator Examination & Guidance and Counseling Subject Area exam (prior to graduation)
- Interview (by invitation)
- International students must have a satisfactory score on the TOEFL exam (minimum score of 550 paper-based, 213 computer-based, or 79 internet-based) for students from countries where English is not the primary language

Satisfaction of minimum University and program requirements does not guarantee admission to a graduate program. Applicants should check with the program for the most up to date admission requirements prior to commencing the application process.

### Counseling Criminal Record Policy Statement

All applicants are advised that in order to complete the program, they must complete internships. Most internship facilities do background checks and will not permit the placement of counselor interns with criminal records. The Department reserves the right to deny program admission to any applicant if it appears that applicant is unlikely to be able to complete the internship requirement due to a criminal record, thus inhibiting their ability to complete the program.
