### Program Description

The Master of Public Administration (MPA) prepares students for administrative positions in the public and not-for-profit sectors. It is designed for those who have significant experience as well as those with little to no prior work experience. Select from two concentrations – Public Leadership & Management or Environmental Policy & Planning. This is the region's only distance (online) MPA program professionally accredited by the Network of Schools of Public Policy Affairs and Administration (NASPAA). ### Admissions Requirements

- FGCU graduate application
- Official academic transcripts from every college or university attended
- Baccalaureate degree from a regionally accredited institution
- GPA of 3.0 or higher on a 4.0 scale in the last 60 hours of undergraduate coursework
- One of the following:
  - Graduate Record Exam (GRE): Total points 100 or higher:  $(\text{GPA} \times 18) + (\text{average percentile rankings verbal \& quantitative for GRE})$
  - Miller Analogies Test (MAT): Total points 100 or higher  $(\text{GPA} \times 18) + \text{MAT percentile rank for intended major}$
  - Graduate degree from regionally accredited institution
- MPA supplemental application
- Three reference rating forms from persons qualified to judge the applicants academic and professional potential
- Letter of application/Statement of career goals, less than 2 pages
- International students must have a satisfactory score on the TOEFL exam (minimum score of 550 paper-based, 213 computer-based, or 79 internet-based) for students from countries where English is not the primary language

Satisfaction of minimum University and program requirements does not guarantee admission to a graduate program. Applicants should check with the program for the most up to date admission requirements prior to commencing the application process.

Spring October 1

- 15 credits in social sciences or business, including 3 hours in quantitative skills
