Program Description

Nurses who wish to pursue careers in education gain advanced knowledge and leadership skills that prepare them to take on the role of nurse educator (MSN). The program uses the core competencies outlined by the National League for Nursing that include curriculum design, teaching, evaluation and more. There are two pathways to admission, one for students with a BSN (traditional) and one for students with a RN.

The RN-MSN pathway is for highly qualified RNs with an associate degree in nursing. Students are admitted to FGCU as undergraduate nursing students. Following the satisfactory completion of 22 credit hours of specified bridge coursework at the undergraduate level, students transition into the MSN program and complete the required 38 credit hours of graduate coursework.

Admissions Requirements

- FGCU graduate application
- Immunization history form
- Official academic transcripts from every college or university attended
- *RN to MSN*: Associate of Arts from a Florida public college or university. Students who do not have an AA degree will be required to meet all FGCU general education requirements.
- *BSN to MSN*: Baccalaureate Nursing degree (BSN) from a CCNE or ACEN nursing program & regionally accredited institution
- Graduate Record Exam (GRE) official scores
- GPA of 3.0 or higher on a 4.0 scale
- Supplemental School of Nursing application through NursingCAS (nursingcas.org)
- Current Resume or CV
- Statement of career goals (300-350 words)
- Evidence of current & unrestricted registration as registered nurse with eligibility for FL RN licensure
- Evidence of minimum 1 year current practice experience as registered nurse in a critical care setting
- Complete Prerequisite coursework with grade of C or higher
- *RN to MSN*: Complete the Bridge Courses (22 credits) with grade of B or higher
- International students must have a satisfactory score on the TOEFL exam (minimum score of 550 paper-based, 213 computer-based, or 79 internet-based) for students from countries where English is not the primary language

Application Deadlines

Fall Priority – May 1

Satisfaction of minimum University and program requirements does not guarantee admission to a graduate program. Applicants should check with the program for the most up to date admission requirements prior to commencing the application process.
