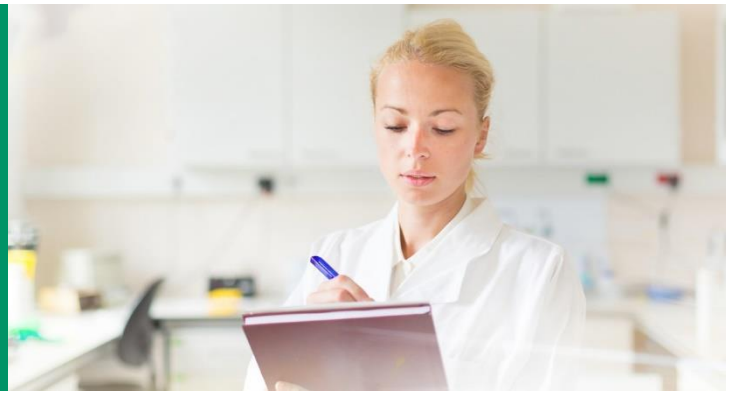

Program Description

The Master of Physician Assistant Studies (MPAS), comprised of didactic education and clinical rotations, prepares students to be effective and collaborative members of a healthcare team. Upon graduation, students will be equipped to sit for the Physician Assistant National Certifying Examination (PANCE) to become eligible for licensure and certification through the National Commission on Certification of Physician Assistants (NCCPA). Admissions Requirements

- FGCU graduate application
- Central Application Service for Physician Assistants (CASPA) application and fee
- Official academic transcripts from every college or university attended
- Baccalaureate degree from a regionally accredited institution
- Graduate Record Exam (GRE) official scores (FGCU/CASPA School Code 2066)
- One of the following:
 - GPA of 3.0 or higher on a 4.0 scale in the last 60 hours of undergraduate coursework
 - Earned graduate degree with minimum GPA of 3.0 or higher on a 4.0 scale
- Overall minimum GPA 3.0 required for all biology, chemistry and physics courses completed
- Three professional letters of recommendation:
 - One from a Physician Assistant (PA)
 - One from a non-PA clinician (MD, DO or NP)
 - One from a Professor or individual who has worked with the applicant in a professional or educational environment (min of 6 months)
- Minimum of 250 hours of direct patient care
- International students must have a satisfactory score on the TOEFL exam (minimum score of 550 paper-based, 213 computer-based, or 79 internet-based) for students from countries where English is not the primary language
- Interview (by invitation from department)
- Required Immunizations & Tb testing

Satisfaction of minimum University and program requirements does not guarantee admission to a graduate program. Applicants should check with the program for the most up to date admission requirements prior to commencing the application process.

Application Deadlines

Fall – CASPA application cycle is September 1 through Jan 15
