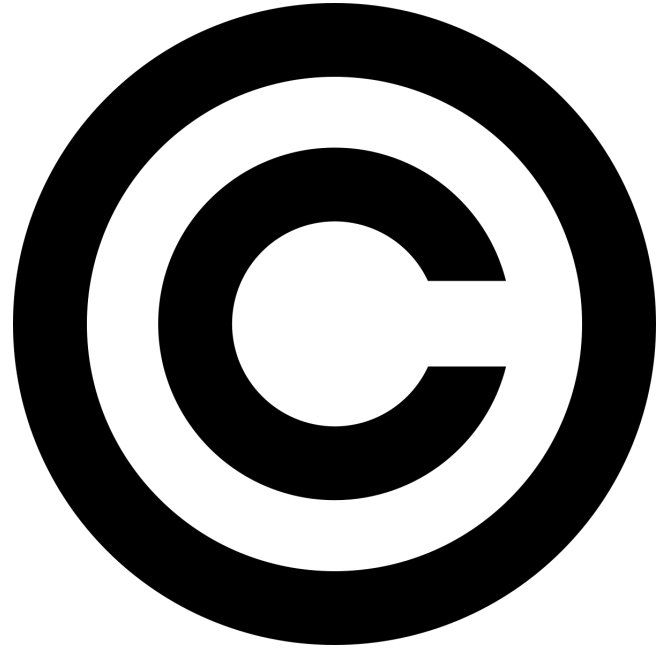

Copyright Basics

- You own what you create.
- Copyright is automatic. You don't have to register for it.
- Copyright is actually a bundle of rights.
 - Reproduce copies
 - Make derivative works
 - Distribute copies
 - Perform publicly
 - Display publicly





You own what you create.

**Avoid giving away your copyright
when you publish your research.**

Option 1:

You retain all rights and license publication.

Option 2:

You transfer your copyright,
but retain some specified rights.

Option 3:

Transfer your full copyright to the publisher.

It doesn't have to be
all or nothing.

1. THIS ADDENDUM hereby modifies and supplements the attached Publication Agreement concerning the following Article:

2. The parties to the Publication Agreement as modified and supplemented by this Addendum are:

3. This Addendum and the Publication Agreement, taken together, allocate all rights under copyright with respect to all versions of the Article. The parties agree that wherever there is any conflict between this Addendum and the Publication Agreement, the provisions of this Addendum are paramount and the Publication Agreement shall be construed accordingly.

4. **Author's Retention of Rights.** Notwithstanding any terms in the Publication Agreement to the contrary, AUTHOR and PUBLISHER agree that in addition to any rights under copyright retained by Author in the Publication Agreement, Author retains: (i) the rights to reproduce, to distribute, to publicly perform, and to publicly display the Article in any medium for non-commercial purposes; (ii) the right to prepare derivative works from the Article; and (iii) the right to authorize others to make any non-commercial use of the Article so long as Author receives credit as author and the journal in which the Article has been published is cited as the source of first publication of the Article. For example, Author may make and distribute copies in the course of teaching and research and may post the Article on personal or institutional Web sites and in other open-access digital repositories.

If you choose to delay the release of your work, access to the full text of your work will be delayed for the period of time that you specify. The citation and abstract of your work will be available through ProQuest and may be available through your institutional repository.

In order to increase the discoverability of your research, theses and dissertations will be made freely accessible in DigitalFGCU, Florida Gulf Coast University's institutional repository. FGCU Library ensures your thesis or dissertation will be digitally preserved and will be continuously migrated as technology advances. In addition to preservation, DigitalFGCU provides greater discoverability for your research. Researchers can easily access theses and dissertations in DigitalFGCU through Google and other search engines, Google Scholar, the FGCU library catalog, as well as WorldCat, the global catalog of library collections.

You have two access options for your thesis or dissertation in DigitalFGCU:

1. **Open Access** will make your thesis or dissertation freely available immediately, which provides the greatest discoverability of the research.
2. **Delayed Release** if you are placing an embargo on your thesis or dissertation. DigitalFGCU will honor your embargo date. Your thesis or dissertation will become freely available through DigitalFGCU once the embargo expires.

Abstract/Description This thesis demonstrates that European civilians were direct targets for attacks during the 1857 Rebellion, that there were apparent gendered experiences for the victims, and that these killings were a result of the latent racial and religious tensions in India, which were deepened by the socio-political reforms introduced by the British. Therefore, through early imperial philosophy, racial and moral anxieties, and their own homogenization of and hostility towards Indians, the British caused themselves to also be treated as an entity by their enemies during the Rebellion, allowing for civilian deaths. British social and moral anxieties were responsible for not only categorizing Indians, but the British

2. Requesting ProQuest to file for U.S. Copyright Registration

- No, do not file for copyright**—I am requesting that ProQuest not file for copyright on my behalf.

 - Required:** Select the checkbox to indicate you have read, understood, and agree to the following:
 - I will pay a fee of \$55.00 (U.S. dollars) to ProQuest for filing on my behalf with the U.S. Copyright Office.
 - I am the sole author of the dissertation or thesis I submitted to ProQuest.
 - I do not acknowledge any co-authors or co-claimants of my work.
 - [See manuscript examples](#) rejected and deemed not by a sole author.

Copyright is automatic. You already have copyright to your thesis. You don't need to register copyright. Don't select this option.

Submitting to ProQuest Summary

- Select “traditional publishing” NOT Open Access for \$95
 - Your thesis or dissertation will be Open Access in DigitalFGCU
- You don't need to register copyright
 - Copyright is automatic. Registering is \$55
- Read every option in ProQuest carefully
