Second reading postponed so need for new motion.</p> <p>Provost commented that he appreciated the efforts to get this done this Spring and he has put his efforts behind accomplishing it which is not a simple thing to do. He is pleased with the outcome and believes he can honor his pledge in this.</p> <p>Morris motion to call the question – motion failed.</p> <p>No further discussion. Vote taken.</p> <p>Thanks all key players including Provost to complete this process.</p> <p>Smith addressed question about what happens with the data once collected. It will become part of the process VPAA uses to evaluate its staff. Need to examine the rule sets to be used for the process – relationships among faculty and Deans to ensure right people receive the right surveys. Info will be going out to faculty to check on these relationships. Will be working to set rules to ensure confidentiality; especially in small units. If report to Director then if using a chair’s job description; faculty will evaluate using chair form. Associate and Assistant Deans left out in this pilot iteration for consideration next year.</p> <p>Lengthy discussion after Snyder raised issue that individual responses could be traced back to the authentication and thus anonymity and confidentiality may not be guaranteed under public requests. May have a chilling effect on responses and validity if faculty cannot be protected. Paper and pencil on a scantron like course evaluations would help with anonymity if they would consider it. Or using envelopes that can be validated and separated before entry. Reminder that public records requests are also public events. Reminder that this is an unlikely situation and the goal is for faculty to participate and feel safe in doing so.</p> <p>Survey to be administered from 2/20 – 3/5 using same function as SAI’s.</p>	Motion to extend discussion a second time was passed.
